A motion was made by Shields seconded by Wampler to approve continued budget for Lenoir City Sales Tax Fund. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting AYE. **Motion Carried.** 

A motion was made by Hines seconded by Henline to approve continued budget for Lenoir City Federal Projects Fund. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting AYE. **Motion Carried.** 

A motion was made by Simpson seconded by Wampler to approve continued budget for Lenoir City Food Service Fund. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting AYE. **Motion Carried.** 

Pursuant to Tennessee Code Annotated Section 9-21-151 State Form CT-0253 report on Debt Obligation was presented to the Mayor and City Council.

A motion was made by Johnson seconded by Shields to adopt initial Resolution authorizing the City of Lenoir City, Tennessee, to borrow funds and incur indebtedness in the principal amount not to exceed \$2,000,000 by obtaining a loan from the Public Building Authority of the City of Clarksville, Tennessee, pursuant to a Loan Agreement to provide funding for certain Public Works Projects, and to fund the incidental and necessary expenses related thereto. A motion was made by Simpson seconded by Wampler to award the 2013-2014 Paving Contract to the lowest bidder Harrison Construction- Old Hwy 95- \$138,900.00 and McGhee Blvd.-\$33,000.00 for a total **of \$171,900.00.** The other bids are as followed: Rogers Group-Old Hwy 95- \$164,278.60 and McGhee Blvd- \$28,896.40 **Total- \$193,175.00** and Greenback Asphalt- Old Hwy 95- \$169,500.00 and McGhee Blvd- \$33,500.00 **Total- \$203,000.00.** The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting AYE. **Motion Carried.**
