

June 1, 2015

The City Council of Lenoir City met in a public hearing at 6:50 p.m. The public hearing was regarding an ordinance to amend the Zoning Map of the City of Lenoir City, Tennessee pursuant to 13-7-204 of the Tennessee Code Annotated, to rezone property located at McGhee Boulevard and Highway 321 from R-2 Medium Density Residential District to C-3 Highway Commercial District. The second public hearing was held at 6:55 p.m. regarding an ordinance to vacate identified Right-of-Way for portion of unimproved alleyway between West 5th and West 6th Avenues and return the underlying property to the adjoining property owners currently identified as Kay and Kenneth Burns. Mayor Aikens and following councilmen were present: Henline, Hines, Johnson, Shields, Simpson, and Wampler. Maggie Hunt and Amber Scott-Kelso were present. James W. Wilburn III and James Scott were absent.

Mayor Aikens asked for comments for citizens regarding an item/ items on the agenda.

A motion was made by Simpson seconded by Wampler to adopt an Ordinance to amend the Zoning Map of the City of Lenoir City, Tennessee pursuant to 13-7-204 of the Tennessee Code Annotated, to rezone property located at McGhee Boulevard and Highway 321 from R-2 Medium Density residential District to C-3 Highway Commercial District. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE**.

Second and Final Reading. Ordinance 2015-06-01-2092-A.

A motion was made by Shields seconded by Simpson to adopt an Ordinance to vacate identified right-of-way for portions of unimproved alleyway between West 5th Avenue and West 6th Avenue and returns the underlying property to the adjoining property owners currently identified as Kay and Kenneth Burns. The City of Lenoir City declares to abandon any rights to this property. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE**. **Second and Final Reading. Ordinance 2015-06-01-2092-B.**

A motion was made by Henline seconded by Hines to adopt an ordinance for the Annual Budget for the General Fund, State Street Aid Fund, Community Development Fund, Downtown VIP Fund, Sanitation Fund, Capital Projects I Fund, Capital Projects II Fund, Lenoir City DEA Fund, and Lenoir City State Drug Fund for the Fiscal Year beginning July 1, 2015 and ending June 30, 2016. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE**. **First Reading.**

A motion was made by Shields seconded by Wampler to adopt an ordinance to provide Revenue for the Municipality of Lenoir City, County of Loudon, Tennessee for Property Tax Year 2015. (\$1.0615) The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE**. **First Reading.**

A motion was made by Johnson seconded by Shields to adopt an ordinance for the Annual General Purpose Fund for Lenoir City Schools for the Fiscal Year July 1, 2015 and ending June 30, 2016. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE**. **First Reading.**

A motion was made by Johnson seconded by Shields to adopt an ordinance for the Annual Sales Tax Fund for Lenoir City Schools for the Fiscal Year July 1, 2015 and ending June 30, 2016. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE**. **First Reading.**

A motion was made by Hines seconded by Johnson to adopt an ordinance for the Annual Federal Projects Fund for Lenoir City Schools for the Fiscal Year July 1, 2015 and ending June 30, 2016. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE**. **First Reading.**

A motion was made by Johnson seconded by Wampler to adopt an ordinance for the Annual Food Service Fund for Lenoir City Schools for the Fiscal Year July 1, 2015 and ending June 30, 2016.) The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting AYE. **First Reading.**

A motion was made by Simpson seconded by Henline to approve the Purchasing Committee's recommendation to award APAC-Atlantic the City Park Drive and Street Garage the paving contract. Bids are as followed: APAC-Atlantic- \$99,750.00 and \$53.00 per ton to pick up asphalt, Greenback Asphalt- \$118,500.00 and \$67.00 per ton to pick up asphalt, and Rogers Group- \$127,900.00 and \$76.00 per ton to pick up asphalt. The following vote was recorded: Henline, Hines, Johnson, Simpson, and Wampler voting **AYE**.

Mayor Aikens discussed that the Police Department Car Camera's and Body Camera's were going to be bought off a GSA contract from Digital-Ally. A motion was made by Wampler seconded by Simpson to authorize the purchase of the Camera's and authorize the payment with the resolution to issuance of interest bearing equipment acquisition Capital Outlay Notes, Series 2015 in an amount not to exceed \$150,000.00, and providing for the payment of said notes. The following vote was recorded: Henline, Hines, Johnson, Simpson, and Wampler voting **AYE**. **Resolution- 2015-06-01-2093.**

Mayor Aikens asked for comments for citizens regarding an item/ items not on the agenda.

A motion was made by Wampler and seconded by Simpson to approve all bills and accounts to be paid when properly approved and funds available. The following vote was recorded: Henline, Hines, Johnson, Shields Simpson, and Wampler voting **AYE**.

A motion was made by Henline and seconded by Hines to adjourn the June 1, 2015 meeting. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE**.
