

July 13, 2015

The City Council met in a Public Hearing at 6:45 P.M. regarding three (3) Ordinances: an Ordinance to establish/erect a “Hidden Driveway” sign for the residents of 373 West Hills Drive in Lenoir City, Tennessee; an Ordinance to designate a Handicapped Parking Space in front of the residence located at 404 Waller street in Lenoir City, Tennessee; and an Ordinance to amend Title 8, Chapter 2, section 8-211 of the Lenoir City Municipal Code regulating the sale of Beer. Motion was made by Hines seconded by Henline to approve a contract with Brown Pearman Russell, LLC for the Housing rehabilitation related services for 2014 HOME Program. The following vote was recorded: Henline, Hines, Shields, Simpson and Wampler Voting AYE. Johnson absent. **Motion Carried.**

Motion was made by Simpson seconded by Shields to approve the Planning Commission's recommendation regarding Ordinance to relinquish portion of certain right-of-ways and the City relinquish any rights to the property associated with the right-of-ways and alleyways: Cherry Street; East Third Avenue; East Fourth Avenue, East Fifth Avenue, and associated alleyways. The following vote was recorded: Henline, Hines, Shields, Simpson and Wampler Voting AYE. Johnson absent. **Motion Carried.**

Motion was made by Wampler seconded by Simpson to approve the Mayor's recommendation to appoint Leon Shields to the Planning Commission. The following vote was recorded: Henline, Hines, Simpson and Wampler Voting AYE. Shields abstain. Johnson absent. **Motion Carried.**

Motion was made by Henline seconded by Hines to approve the personal's recommendation to approve the employment of Tyrel Lorenz to the Police Department. The following vote was recorded: Henline, Hines, Shields, Simpson and Wampler Voting AYE. Johnson absent. **Motion Carried.**

Motion was made by Shields seconded by Simpson to approve the Mayor's recommendation to appoint Gillis Morgan to the Lenoir City Beer Board. The following vote was recorded: Henline, Hines, Shields, Simpson and Wampler Voting AYE. Johnson absent. **Motion Carried.**

Mayor Aikens asked for comments from citizens regarding an item/items not on the agenda.

Motion was made by Wampler and seconded by Henline to approve all bills and accounts to be paid when properly approved and funds available. The following vote was recorded: Henline, Hines, Shields, Simpson and Wampler Voting AYE. Johnson absent. **Motion Carried.**

Motion was made by Henline and seconded by Hines to adjourn the July 13, 2015 meeting. The following vote was recorded: Henline, Hines, Shields, Simpson and Wampler Voting AYE. Johnson absent. **Motion Carried.**
