A motion was made by Shields and seconded by Henline to approve the minutes of the September 25, 2017 meeting. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE.**

Mayor Aikens asked for comments from citizens regarding an item/items on the agenda.

A motion was made by Henline and seconded by Simpson to add two (2) items to the agenda. The item will be noted as Number 8 and Number 9. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE.**

A motion was made by Simpson and seconded by Wampler to approve amendment to Downtown Streetscapes Phase II contract with Tennessee Department of Transportation (TDOT) for time extension. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE.**

A motion was made by Johnson and seconded by Simpson to approve Purchasing Committee's recommendation regarding purchase of backhoe from Chattanooga Tractor in the amount of \$81,386.00. The following vote was recorded: Henline, Hines, Johnson, Shields, Simpson, and Wampler voting **AYE.**

A motion was made by Simpson and seconded by Shields to approve Planning Commission's recommendation regarding adoption of Ordinance amending Title11, Chapter 2, Sections 11-204, 11-403, 11-404, 11-405, 11-415, and 11-417 of the Lenoir City Municipal Code to prohibit the use of storage containers as defined herein within the existing residential districts of the City of Lenoir City.
