The City Council of Lenoir City met in its regular scheduled meeting at 6:00 P.M. Mayor Tony Aikens and the following Council Members were present: Hines, Shields, Simpson, Wampler, and Brandon. Councilman Johnson was absent. Jim Wilburn, Maggie Hunt, and Gregg Harrison were also present.

A motion was made by Mr. Brandon and seconded by Mr. Shields to approve the minutes of the September 9, 2019 meeting. The following vote was recorded: Hines, Shields, Simpson, Wampler, and Brandon voting **AYE**. Johnson **ABSENT**

The following residents from Harrison Glenn spoke on concerns within the subdivision

Glen Davis -concerned with the addition of new homes that may create traffic issues, and there only being one entrance and exit.

Bob Pollock- concerns were stormwater issues, street lighting timing, and one entrance and exit.

Jim Holson- stormwater issues, safety concerns with only one entrance and exit.

Donna Allen- concerned with only having one entrance and exit and the amount of time it would take for emergency personnel to arrive.

Mayor Aikens addressed the concerns and Chief White will check on the timing for the lighting, Ms. Beth Collins will continue working with developers about the possibility of putting in another entrance and/or exit. Mr. Greg Buckner will continue to communicate with developers to stay on top of the flooding issue until we get sod in place.
