The Lenoir City Council met in its regularly scheduled meeting on Monday, January 27, 2025 at 6:00 P.M. Mayor Tony Aikens and the following Council Members were present: McNabb, Wampler, Kennedy, Shields, Brandon, and Simpson. Amber Scott Kelso, Maggie Hunt, Jim Wilburn, LaVonne Barbour, and Walter Johnson were also present.

A motion was made by Brandon and seconded by Shields to approve the minutes of the January 13, 2025 meeting. The following vote was recorded: McNabb, Wampler, Kennedy, Shields, Brandon, and Simpson voting **AYE**.

Mayor Aikens requested to remove items 2. and 3. from the agenda since the Finance Director was not at the meeting.

A motion was made by Wampler and seconded by McNabb to accept the agenda as written, with the exception of removing Agenda Items 2. and 3. The following vote was recorded: McNabb, Wampler, Kennedy, Shields, Brandon, and Simpson voting **AYE**.

Mayor Aikens asked for comments from citizens regarding an item/items on the Agenda.

Ms. Christy Via spoke on Agenda Item #8.

Pastor David Smith spoke on Agenda Item #8.

A motion was made by Simpson and seconded by McNabb to adopt Resolution regarding commitment of funds for the Community Development Block Grant for Streambank Stabilization Phase II. The City's portion will be \$127,551.00 (amend Stormwater Department budget to reflect this), and total grant \$250,000.00. The following vote was recorded: McNabb, Wampler, Kennedy, Shields, Brandon, and Simpson voting **AYE**.

A motion was made by Shields and seconded by Wampler to approve the Purchasing Committee's recommendation to approve bid for Tactical Training Facility from Resolute Construction for \$1,595,000.00. The following vote was recorded: McNabb, Wampler, Kennedy, Shields, Brandon, and Simpson voting **AYE**.

A motion was made by Brandon and seconded by Kennedy to approve the Purchasing Committee's recommendation to declare 1994 Pierce Fire Apparatus as surplus property (information attached). The following vote was recorded: McNabb, Wampler, Kennedy, Shields, Brandon, and Simpson voting **AYE**.

A motion was made by Kennedy and seconded by Brandon to approve hiring Mr. Daniel Crass to fill full-time vacancy in the Parks and Recreation Department. The following vote was recorded: McNabb, Wampler, Kennedy, Shields, Brandon, and Simpson voting **AYE**.




